

NOTICE OF PUBLIC MEETING TO DISCUSS PROPOSED TAX RATE

The El Paso Independent School District will hold a public meeting at 5:00 PM, August 15, 2017 in the Education Center Board Room, 6531 Boeing Drive, El Paso, Texas. **The purpose of this meeting is to discuss the school district's tax rate that will be adopted. Public participation in the discussion is invited.**

The school district has elected to adopt a tax rate after receiving the certified appraisal roll from the chief appraiser(s) of the appraisal district(s) and after adopting the 2017-18 budget on June 21, 2017. In accordance with Texas Tax Code, Section 26.05(g), the chief appraiser(s) of the appraisal district(s) in which the school district participates has certified to the assessor for the school district an estimate of the taxable value of property in the school district as provided by the Texas Tax Code, Section 26.01(e). This Notice is published in accordance with the Texas Education Code, Section 44.004(c). The Board of Trustees must adopt a tax rate by September 30, 2017.

The tax rate that is ultimately adopted at this meeting or at a separate meeting at a later date may not exceed the proposed rate shown below unless the district publishes a revised notice containing the same information and comparisons set out below and holds another public meeting to discuss the revised notice.

Under state law, the dollar amount of school taxes imposed on the residence homestead of a person 65 years of age or older or of the surviving spouse of such a person, if the surviving spouse was 55 years of age or older when the person died, may not be increased above the amount paid in the first year after the person turned 65, regardless of changes in tax rate or property value.

Notice of Rollback Rate: The highest tax rate the district can adopt before requiring voter approval at an election is \$1.3529. This election will be automatically held if the district adopts a rate in excess of the rollback rate of \$1.3529.

Fund Balances

The following estimated balances will remain at the end of the current fiscal year and are not encumbered with or by a corresponding debt obligation, less estimated funds necessary for operating the district before receipt of the first state aid payment.
